### **Acknowledgment of Risks, Injury & Obligations:**

I acknowledge and understand that whilst participating in such activity:

- I may be injured, physically or mentally, or may die;
- My personal property may be lost or damaged;

- The conditions in which the activity is conducted may vary without warning

### **Personal training :**

Personal training clients are not permitted to partake in normal classes unless special permission is given by the instructor to do so.

Personal training clients will be subject to paying five session upfront before personal training shall commence.

Personal training clients, 24 hours shall be given to the instructor if the session needs to be cancelled, failing to do so shall result in the client losing said session.

Personal training clients are subject to all normal rules as listed in this membership pack and gym rules which can be found inside the gym.

### **Cancelation:**

Members wanting to cancel their gym contract can and must do so in written email form. Said gym contract will be cancelled within 30 working days of email date, if said member is up to date with payments no other fees will reflect. Members willing to sign up again after cancellation may do so at their own leisure and will not be subject to sign up fees, as long as said member was not removed from Top Primate Academy for breaching terms and conditions as listed in this membership form.

**Administration:**

- No shoes will be allowed on the training mats at all times, unless member is wearing/participating in the boxing classes.
  - No use of shoes on kicking/punching bags and also kick/focus pads
  - Appropriate footwear for skipping/running must be on hand at all times.
  - A shirt and appropriate shorts must be worn at all times while in the facility.
  - Memberships are not refundable or transferable.
  - All weights and equipment must be put back after use.
  - Photo ID cards must be carried and shown upon request.
  - Shared gym access with a non-member will result in forfeiture of membership effective immediately.

The individual payment instructions so authorised to be issued must be issued and delivered as follows: **monthly**.

In the event that the payment day falls on a Sunday, or recognised South African public holiday, the payment day will automatically be the very next ordinary business day. Furthermore, if there are insufficient funds in my account to meet the obligation, you are entitled to track my account and represent the instruction for payment as soon as sufficient funds are available in my account.

Payment instructions due in December will be debited on the **1st** (date).

I/We understand that withdrawals hereby authorised will be processed through a computerised system provided by the South African Banks. I also understand that details of each withdrawal will be printed on my bank statement. Such must contain a number, which must be included in the said payment instruction and if provided to me should enable me to identify the Agreement. This number must be added to this form before the issuing of any payment instruction.

**Mandate**

I/We acknowledge that all payment instructions issued by you shall be treated by my/our above-mentioned Bank as if the instructions have been issued by me/us personally.

**Cancellation**

I/We agree that although this Authority and Mandate may be cancelled by me/us, such cancellation will not cancel the Agreement. I/We shall not be entitled to any refund of amounts which you have withdrawn while this Authority was in force, if such amounts are legally owing to you.
