Personal training clients are subject to normal rules as listed in this membership pack and gym rules which can be found inside the gym. Personal training sessions are subject to an expiration time of one full month/ 30 day whichever one comes first.

#### Cancellations:

Members wanting to cancel their gym contract can and must do so in written email form. Said gym contract will be cancelled within 30 days of email date, A one month membership fee will be charged upon cancellation, reflecting your chosen membership, if said member is up to date with payments no other fees will reflect, all contracts are subject to a minimum of 6 months before cancellation will commence. Members willing to sign up again after cancelling may do so at their own leisure and will not be subject to sign up fees, as long as said member was not removed from Top Primate (Pty) Ltd for breaching terms and conditions as listed in this membership form.

#### ADMINISTRATION:
